SCHOLARSHIP PROGRAM QUALIFICATIONS AND PROCEDURES**

1. Scholarship or fellowship grants shall be made to colleges and universities rather than to students directly.
2. The colleges and universities shall be accredited by appropriate accrediting bodies and shall confer a Bachelor's degree or higher degrees with a major in real estate or a related field with an emphasis in real estate.
3. Grants and student loans shall be made only to colleges and universities which at the time of receiving the grants or loans are exempt from federal income taxation under Section 501 (c) (3) of the Internal Revenue Code of 1954, or any later section of the Internal Revenue Code which amends or supersedes the said section and only if at the time of receiving the grant or loan, the colleges or universities are exempt from federal taxation under the provision of Sections 2055 and 2522 of the Internal Revenue Code of 1954, or any later sections of the Internal Revenue Code which amend or supersede the said sections.
4. Applicants shall have successfully completed at least two real estate courses accredited by a degree granting college or university. Or, completed at least one real estate course and be enrolled in a second with a letter of recommendation from the professor or academic officer.
5. Applicants shall be definitely committed to the pursuit of a program of study leading to a **Bachelor's degree or higher with a major in real estate or in a related field with an emphasis in real estate and intend on pursuing a career in real estate.** Past recipients of this scholarship can re-apply.
6. Members of the Foundation Committee can not vote or participate on any applicant which may be related to them in any way by lineal descent, ancestor, brother or sister of such a member.
7. Applicants shall agree to present to the Foundation one copy of any thesis, dissertation, or major research paper produced as part of the academic program pursued as a result of grants or scholarships made by the Foundation. If theses, dissertations, or research papers can be released to the Foundation only with the permission of the colleges or universities, applicants shall employ their best effort to obtain such permission.
8. Applications shall be submitted only by an official form of the Foundation on which all information requested shall be furnished. A statement by a professor or academic officer on the general merit and financial need of the student on whose behalf an application has been approved and is being transmitted is an important component of the information requested.
9. Applications shall be transmitted to the Foundation only by professors or academic officers of the college or universities at which applicants are enrolled, on a full-time basis.
